FSS: 810.02(1)(B)(2)-8 1,500.00

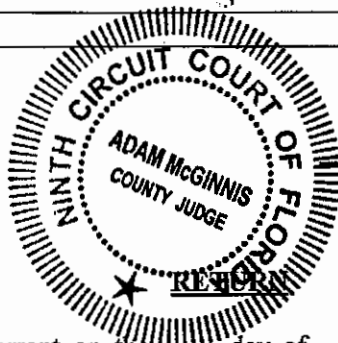
C2 GRAND THEFT 3RD DEGREE (>\$300, <\$5,000)

AFFIDAVIT FOR ARREST WARRANT

STATE OF FLORIDA
COUNTY OF ORANGE

Comes now the affiant, **Detective Andrew Motes**, a sworn law enforcement officer, to wit: a **Police Officer for the City of Ocoee Police Department, Orange County, Florida**, before **The Honorable Adam McGinnis**, Judge, in and for Orange County, Florida, Ninth Judicial Circuit, who makes this affidavit and states under oath that affiant has probable cause to believe that certain laws have been violated Orange County, Florida, and that on/between **October 26, 2016**, the Defendant, **Patricia Lea MacFadden**, did violate Florida State Statute(s), and commit the offense(s) of:

- C1 BURGLARY OF STRUCTURE FSS: 810.02(1)(B)(2)-8
- C2 GRAND THEFT 3RD DEGREE (>\$300, <\$5,000) FSS: 812.014(2)(C)(1)-3

YOUR AFFIANT, IN THE COURSE OF HIS/ HER OFFICIAL DUTIES, HAS COME TO INVESTIGATE:

On October 26, 2016, Officer Beck provided a report as follows:

On October 26, 2016 at approximately 1800 hours, I responded to 735 Lakeview Drive in reference to a burglary over with.

Upon arrival, I met with victim and complainant Christopher Wilson, who stated that at approximately 1745 hours he arrived home only to find his shed in the backyard had been burglarized and many of his tools were stolen.

Wilson reviewed his home video surveillance and was able to capture footage of the suspect. At approximately 1153 hours, a heavysset blond haired white female wearing a silver top and purple slacks pulls up into Wilson's driveway in a maroon colored Chevy Suburban/Tahoe with dark tint. The female walks up to the front door, knocks and rings the doorbell only to find no one was home at the time. The female then gets back into the vehicle and drives off. Moments later, the female is seen in Wilson's backyard entering his shed. It is unclear from the video of how the female entered the backyard but it is believed she entered through the back gate. The female is seen collecting multiple tools and items in the shed and exits the shed carrying the items. It is unclear at this time

how the female exited the premises.

Wilson provided a sworn written statement and would like to press charges.

Wilson was able to provide pictures of the female suspect and vehicle, however, is unable to upload or email the video at this time. I took pictures of the scene and placed them into Ocoee Police Evidence. I attempted to dust the scene and doorbell for latent prints but was unsuccessful in gathering any viable prints.

Items Stolen:

- 1 Dewalt Chainsaw valued at \$400 dollars
- 1 Dewalt Hammer Drill, 1 Dewalt Flash light, 1 Dewalt Saw combined value of \$400 dollars
- 2 Large Batteries, 2 Small Batteries, 2 Large Chargers, 1 Small Charger combined value of \$380 dollars
- 1 Blue Tree Poll Chainsaw valued at \$300 dollars
- 1 Dewalt Blower valued at \$200 dollars

No serial numbers were provided.

Combined total is \$1680 dollars.

On October 27, 2016, Your Affiant, Detective Motes, was assigned this case for further investigation.

Upon reviewing the video surveillance Your Affiant made an attempt to identify flyer with photographs he obtained from the video surveillance and released it to local law enforcement.

Your Affiant was contacted by the victim, Christopher Wilson, who stated he had placed video surveillance from this incident on the internet. Your Affiant received a phone call from an anonymous female stating she had seen the video that was posted and knew the female was Patricia MacFadden with a maiden name of Patricia Walding.

Your Affiant conducted a search in DAVID, Driver and Vehicle Information Database, and located a female who appeared to be the female in the video surveillance as Patricia Lea MacFadden DOB 08/21/1972. MacFadden was showing an address at 1005 Kimball Dr. Ocoee, Fl. 34761 which Your Affiant responded to. Upon Your Affiant's arrival he made contact with the current resident who stated MacFadden no longer lived there, but the neighbor at 1007 Kimball Dr. may know where MacFadden lives. Your Affiant made contact with residents at 1007 Kimball Dr. and asked if they knew where Your Affiant could locate MacFadden. The male stated he did not know, but his daughter is friends with her. The male provided me with his daughters, Kim, phone number, Your Affiant called Kim and she informed him she had not talked to MacFadden in a while but she believed MacFadden lived with her parents on Honolulu Dr. but she could not provide me with the numerical.

Your Affiant conducted a search in DAVID and located a female, Blanche Walding, who lives at 8536 Honolulu Dr. Orlando, Fl. Your Affiant responded to the address on Honolulu Drive and made contact with William Walding who stated he was Patricia Macfadden's father. Your Affiant asked William Walding if he knew why Your Affiant was at his residence and he stated he saw the video of his daughter on the internet. Your Affiant showed William Walding the attempt to identify flyer he made, with still photographs from the surveillance video, to confirm that we were talking about the same video. As Your Affiant showed William the flyer he stated yes that's my daughter, I already saw the video. Your Affiant requested from William if he knew where his daughter was and he stated he did not. William Walding also informed Your Affiant Macfadden is usually at his residence all the time, but on this day she left to go take her children to school and has yet to return. Your Affiant left William Walding with his business card and requested that he have MacFadden call Your Affiant.

On October 28, 2016, Your Affiant was contacted by Wilson informing him he received an email from MacFaddens mother, Blache Walding, and requested to meet with him to return his property that was stolen. Your Affiant informed Wilson to inform Mrs. Walding to meet him at the Ocoee Police Station, Wilson informed me a short time later Mrs. Walding did not want to meet at the Ocoee Police Station, but would meet him at Wal-Mart located at 10500 W. Colonial Dr. Ocoee, FL 34761 at 1230 hours.

Your Affiant responded to Wal-Mart, met with Wilson and Mrs. Walding to return Wilson his property. Mr. and Mrs. Walding were on scene and had all of Wilson's property in the back of their blue in color Dodge truck. Your Affiant asked Mr. Walding where he retrieved the property and he informed Your Affiant he had to drive to three different locations, friends of MacFaddens, to retrieve the property. Mrs. Walding provided Your Affiant with a sworn written statement stating she retrieved the items from locations where MacFadden informed her the stolen property was and she met with Your Affiant and the victim, Chris Wilson, to return him his property.

Your Affiant again requested that the Walding's have MacFadden contact him by Monday afternoon.

Photographs were taken of the property.

On October 31, 2016, Your Affiant received a phone call from Mrs. Walding stating MacFadden was with her and she was going to bring MacFadden to the Ocoee Police Department to speak with Your Affiant.

Upon MacFaddens arrival at the Ocoee Police Station Your Affiant escorted her to interview room 1 which is audio and video recorded. MacFadden informed Your Affiant of the following:

On October 26, 2016 she was approached by a women while she was in the area of Little Spring Hill Road who introduced herself as Cindy or Sherri Lee, MacFadden could not remember the females first or last name, she could only remember her middle name due to the fact they shared the same middle name. The unknown female claimed she knew MacFadden, but MacFadden was not sure if she knew the female, therefore she went along with it to be polite. The unknown female informed MacFadden she was in charge of a house that was foreclosed on by a bank. The house was close by and the unknown female asked MacFadden if she was interested in any tools or anything of that nature. MacFadden replied she was, the female informed MacFadden where the house was and to meet her there shortly.

Upon MacFaddens arrival she did not see anyone at the residence, but she exited her vehicle to ring the doorbell anyway to see if anyone was home. No one answered the door therefore MacFadden left the residence, as she was leaving the residence she observed the unknown female by the back gate. MacFadden informed the female she was unaware that she wanted her to meet her at the back gate, at that point MacFadden asked the female what kind of items were in the shed. The female then slowly exited her vehicle, unlocked the gate with a key, and informed MacFadden to slide the gate open. MacFadden then went inside the shed, looked around, then returned to tell the female she was interested. MacFadden mentioned the camera on the property and the female laughed, then assured MacFadden she was allowed to be on the property. MacFadden asked the unknown female what she was allowed to take at this time and the female informed her only tools, the unknown female informed MacFadden when she was done just to pull the doors shut and the female would lock up the doors at a later time. MacFadden stated she made two separate trips on October 26, 2016 to Wilson's residence to take items.

On the following day, October 27, 2016, MacFadden stated she was on her way back to Wilson's residence to meet the unknown female there again, when she received a phone call from her sister in law informing her there was a video of her on Facebook stealing. MacFadden did not proceed to Wilson residence after receiving the phone call even though she was supposed to meet the unknown

female there.

As Your Affiant was speaking with MacFadden she showed him an email she wrote to the victim, Wilson. In the email MacFadden refers to herself as "MacFaddens Friend" she conceals her real identity from Wilson during the email. Your Affiant requested that MacFadden send him the email, but I have yet to receive it. Your Affiant spoke with Wilson about this email, asked him he he ever received said email, and he stated he did not. The only email he received was from MacFadden's mother.

During the interview with MacFadden, Your Affiant asked MacFadden if anyone saw her at Wilson's residence on Wednesday October 26, 2016, who can confirm she was with this unknown women and she stated yes. MacFadden informed Your Affiant, Wilson's neighbor, 701 Crystal Dr. Ocoee, Fl. 34761, not only saw her but the two had a conversation about their dogs. MacFadden informed Your Affiant the neighbor she spoke with was an older lady with white hair, had a small dog, and if Your Affiant was looking at the back gate of Wilson's residence it would be the residence to the left.

Your Affiant responded to 701 Crystal Drive and made contact with Gale Oler. Oler has white hair, a small white dog, and lives to left of Wilson's residence. Your Affiant asked Oler if she spoke with a female on Wednesday October 26, 2016 that was by Wilson's back gate and she informed Your Affiant she did not. Your Affiant asked Oler if she saw two females by Wilson's back gate on Wednesday, again Oler informed Your Affiant she did not. Your Affiant showed Oler a picture of MacFadden and asked her if she had spoken to MacFadden about their dogs and let their dogs play together and Oler informed Your Affiant she had never seen MacFadden nor has she ever spoke with her. Oler stated the area by Wilson's back gate is a bus stop for children and cars park their quite often.

Your Affiant also conducted many searches in an effort to locate the unknown female by the name of Sherri or Cindy Lee, but I was unsuccessful in locating any one with that name who matches the general description MacFadden provided Your Affiant with.

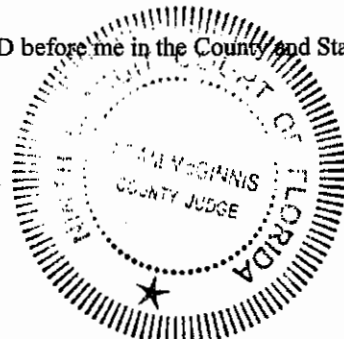
Your Affiant has probable cause to charge Patricia MacFadden with BURGLARY OF STRUCTURE pursuant to FSS: 810.02(1)(B)(2)-8 due to the fact MacFadden entered Wilson's shed and at the time of entering the structure, shed, MacFadden had the intent to commit the offense of grand theft.

Your Affiant has probable cause to charge Patricia MacFadden with GRAND THEFT 3RD DEGREE (>\$300, <\$5,000) pursuant to FSS: 812.014(2)(C)(1)-3 due to the fact MacFadden knowingly and unlawfully obtained the property of Wilson with the intent to temporarily and/or permanently deprive Wilson of the right or any benefit of said property.
